

**CCSL Minutes
February 2, 2010**

Called to order by Rebecca Berryman.
16 members in attendance.

Schedule: Rebecca will work on the schedule for meets this season. Each team gave blackout dates as follows:

Numbers: All teams expect to have about the same number of swimmers.

Finances: Bank account has balance of \$26,426.40 as of today. If we have a three year balance over \$25,000, we need to worry about tax bracket. Rebeccas proposes charging \$5 per swimmer instead of \$20 for one season only to bring down money coming in and spend what we have. Motion is made, seconded, and passed unanimously.

Swim Suits: In accordance with changes to swim suit restrictions in South Texas, the league will include wordage provided by Hays in the 2010 bylaws. Motion is made, seconded, and passed unanimously. It is noted that coaches need to communicate this new rule to swimmers and parents as soon as possible.

Swim Wear Restrictions: Swimmers shall be limited to one swimsuit, which shall be constructed of a woven/knit textile material, permeable to water and air, constructed so as not to aid in buoyancy, and shall not contain zippers or other fastening systems. In addition, the suit shall be constructed so that the style/shape for males shall not extend above the waist or below the top of the kneecap, and for females, shall not extend beyond the shoulders of below the top of the kneecap, and it shall not cover the neck.

Legal Times for Champs: The matter was discussed to require 2 legal times to qualify for Champs instead of 1, and to add this change to the Bylaws.
